

Guidelines for submitting an abstract

International Meeting on Chemical Sensors, 22 – 26 June 2025, Freiburg

Submission, Deadline

- Abstracts have to be submitted exclusively online.
- Deadline for application is 3 December 2024 23:59:59 CET.
- Posters are equally submitted as abstracts related to the respective topics.
- Alterations and corrections may be executed previous to the deadline.

Topic, Language

- Each contribution must relate to one of the given topics:
 - Chemical sensors
 - Biosensors
 - Mechanisms, modeling and simulation
 - Emerging sensing technologies
 - Sensing materials
 - Electrochemical and metal oxide sensors
 - Optical and luminescent sensors
 - MEMS/NEMS sensors and microfluidic devices
 - Flexible, stretchable and wearable sensors
 - Sensors for safety, environmental and healthcare applications
 - Intelligent processing of sensing data
 - Hydrogen Sensors
 - Applications of Chemical Sensors
 - Sensors for harsh environments
- Abstracts may be submitted and presented in English.

Size, Content

- The abstract is limited to a maximum of 600 words (without spaces), up to 2 tables and 2 images.
- The use of the word-template is mandatory.
- The title should be short and significant. The text must be orthographically suitable for publishing.
- The paper should be structured as follows: Summary (max. 100 words), Content of your research, References
- Please keep the titles "Summary" and "References" in the word-template. The content section can be structured freely according to your research.
- Concerning the methods it has to be clear if the study is prospective or retrospective. Statistical procedures have to be specified.
- The setup of experimental studies has to be documented.
- The abstract has to contain all relevant data and figures. Abbreviations must be defined at first usage.

- The usage of special formatting should be limited. The correct replication in all media cannot be guaranteed.
- It is not allowed to submit an abstract several times to different topics of the congress.
- The number of authors per abstract is limited to 10. The presenter must be listed first.

Conditions, Requirements

- The presenter is responsible for the compliance with data protection, copyrights, ethic regulations and laws on animal protection, and export control. Abstracts must be unclassified and approved for public release. The abstracts must not promote research in fields of work that are illegal in the Federal Republic of Germany, such as the development of CBRN weapons or anti-personnel mines.
- To assure the anonymous review it is not allowed to mention any names or locations in the paper.
- Accepted abstracts will be published as conference proceedings or book of abstracts.
- Authors' fees or royalties cannot be claimed.
- All listed authors have to consent to the abstract text as well as to their publication in all congress media.
- Any potential conflict of interest has to be disclosed.

Review, Registration

- All submitted abstracts will be reviewed triple blind.
- Evaluation criteria are: Aim and objective, material and methodology, results and conclusions.
- Abstracts that show formal errors (multi-submission, not anonymised) will be rejected.
- E-Mail notifications about acceptance or refusal will be sent to the presenting author subsequent to the reviewing process.
- The presenting author is expected to participate on-site and give a live presentation in Freiburg.
- Each presenter must register for the congress before 28 February 2025 in order to confirm the presentation in Freiburg.
- If the presenter has not registered by that time, the contribution will be deleted from the programme.
